The Commissioner, Municipal Corporation, Solan Distt. Solan HP on behalf of Governor of H.P. invites the online bids -cum-auction (in Two bid system- Technical bid and financial Bid) for "Letting out space in Thodo Ground at Solan Town for setting up swings (Jhulla and Joy rides Like Giant wheel, Columbus ride, train rides and other joy rides) during State level Shoolini fair, 2023" scheduled to be organised w.e.f. 23.06.2023 to 25.06.2023, from experienced & registered vendors/event managers having experience of construction/installation of such Swings(Jhulla and Joy rides Like Giant wheel, Columbus ride, train rides and other joy rides).

**Availability Of Bid Document and mode of Submission:** The Bid Document is available online and Bid should be submitted in online mode on website <https://hptenders.gov.in> Bidder would be required to register on the web-site which is free of cost. For submission of bid, the bidder is required to have digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). Aspiring bidder who have not obtained the user ID and password for participating in e-tendering in M.C. may obtain the same from the web site. <https://hptenders.gov.in> Digital Signature is mandatory to participate in the e-tendering. Bidder already possessing the digital Signature issued from authorized CAs can use the same in this tender.

- vi) Earnest Money Deposit as prescribed in the tender Notice Rs.2.00lacs (Two lakh )may be attached in the shape of FDR/Demand Draft in favor of Commissioner, Municipal Corporation, Solan payable at Solan.


**SUBMISSION OF ORIGINAL DOCUMENTS:-** The Bidder are required to submit (a) original demand draft towards the cost of Bid Document and (b) original Bid Security /Earnest Money Deposit (EMD) and other Technical Documents /Eligibility information in the O/O the Commissioner, Municipal Corporation, Solan as specified in key dates on tender Opening Date, Failing which the Bids will be declared non-responsive.

**BID OPENING DETAILS:** The Bids shall be opened **09.06.2023** upto 4.00 P.M. in the office the Commissioner, Municipal Corporation, Solan by the authorized Committee. In their interest the tenderers are advised to be present along with original documents at the opening of tenders, If the Office happens to be closed on the date of opening of the bid as specified, the bids will be opened on the next working day at the same time and venue.

**SPECIAL TERMS AND CONDITIONS OF CONTRACT:**

- 1 Fitness Certificate from the appropriate authority i.e. of the complete equipments installed in the Amusement Park on daily basis shall be arranged by the successful bidder on its own from Mechanical Engineer authorised.
2. The highest bidder will arrange insurance Cover Certificate in respect of each person riding the Amusement Games.
3. All Rules and Regulations of Municipal Corporation, Solan/Distt. Solan Administration meant for putting up Amusement Games at the above said event, shall be adhered in all respect by the highest bidder.
4. The highest bidder shall ensure the norms of sound and smoke pollution while plying the equipment's.
5. The area of installation of the Amusement Park/Jhulla will be 1800.00Sqmtr as decided by the Committee constituted i.e Municipal Engineer, Junior Engineer and Sanitary Inspector. Any violation of area, Charges per Sqm will be charged extra of the quoted rates.
6. The Swings, Jhullas etc. shall be erected strictly as per "INDIAN STANDARD RECOMMENDATIONS FOR THE FIRE PRECAUTION MEASURES".
7. The Successful bidder/traders shall obtain temporary electricity connections from H.P. State Electricity Board Ltd. And the electricity charges shall be paid by the successful bidder. Sufficient Light arrangements be made in the Thodo Ground by the bidder around the Swings.
8. No other stalls except Jhulla and Joy rides will be allowed to the successful bidder in the Amusement Park area. Any activity other than the said contract, if found carried out by the successful bidder, the entire contract shall be cancelled immediately and the entire earnest money deposited with the Municipal Corporation, Solan shall be forfeited apart from suitable action as deemed fit shall be initiated.
9. The highest bidder shall ensure the complete cleanliness in and around the Amusement Park and proper dustbins be kept at proper distance.
10. All joy rides should be well polished as well as the tin sheets used for cordon the area designating for installing Amusement Park.
11. The successful bidder shall ensure the complete safety of the Jhullas/Joy Rides etc and any mis-happening whatsoever happens shall be the sole responsibility of the agency.
12. Any dispute shall be subject to the jurisdiction of Solan only.
13. All the joy rides shall be allowed for a week i.e. three days for play 23, 24 and 25 June 2023 and two days for installation i.e. 21 to 22 June, 2023 and 3 days for removal of all joy rides/Jhulla upto 28.06.2023 after that extra charges will be charged as decided by the Committee.

14. The Successful bidder shall be required to deposit 25% of the bid amount within 24 hours of awarding of Tender in his/her favour, next 50% by 21th June 2023 and he /she shall be required to deposit the **remaining bid amount positively before 24<sup>st</sup> June 2023 by 5:00PM** .The above said payment shall be made by way of Demand draft/cash payable to Commissioner, Municipal Corporation, Solan office . Non depositing of full bid amount by due date shall result in cancellation of contract and forfeiture of Earnest Money and the entire amount deposited by the defaulter bidder till date and the contract shall be awarded to the next bidder.
15. If any complaint from general public regarding misbehaviour by the employee engaged by the bidder, Rates of Jhulla/rides found/ received in this office, necessary action under law will be initiated against you. Successful bidder will have to issue identity card to the employees engaged and compulsorily be tagged on the shirt of the employee with seal/stamp of Bidder.
16. Bidder will have to display sign board of rates fixed by the Municipal Corporation, Solan in front of every Jhulla/rides before starting the Jhulla/ rides.
17. Rate/charges of Jhulla and Joy rides Like Giant wheel, Columbus ride, train rides and other joy rides fixed by Municipal Corporation, Solan Rs. 50/-per person including GST and for children age upto 12 years old, rate will be Rs. 30/-only including GST in all type of Jhulla, If any complaint from the general public received regarding Rate/charges of Jhulla MC will charge Fine Rs. 1,00,000/- per day and Vendors will be blacklisted for the next time
18. **All the Technically qualified bidders will be called for open Auction, after the opening of technical Document and before the opening of financial Bids. The highest bidder in open auction will be compared with online bidder, whichever is found highest, Tender will be awarded accordingly.**
19. The Commissioner, Municipal Corporation, Solan reserves the right to reject any or all tenders without assigning any reason.
20. After successful completion of the Mela the successful bidder shall vacate the space i.e. Thodo ground let out to him by 28.06.2023 failing which he shall be liable to pay Rs. 5000/- per day that shall be deducted from Security deposit paid by him.
