For submission of bid, the bidder is required to have digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). Aspiring bidder who have not obtained the user ID and password for participating in e-tendering in M.C. may obtain the same from the web site. <https://hptenders.gov.in> Digital Signature is mandatory to participate in the e-tendering. Bidder already possessing the digital Signature issued from authorized CAs can use the same in this tender.

Cover 2: Shall Contain "BOQ/Financial Bid", Where contractor will quote his offer for each item.

**SUBMISSION OF ORIGINAL DOCUMENTS:-** The Bidder are required to submit (a) original demand draft towards the cost of Bid Document and (b) original Bid Security /Earnest Money Deposit (EMD) and other Technical Documents /Eligibility information in the O/O the Executive Officer Municipal Council Solan as specified in key dates Sr.No. 4 on tender Opening Date, Failing which the Bids will be declared non-responsive.

**BID OPENING DETAILS:** The Bids shall be opened 16.06.2022 upto 2.30 P.M. in the office the Executive Officer Municipal Council Solan by the authorized officer. In their interest the tenders are advised to be present along with original documents at the opening of tenders, If the Office happens to be closed on the date of opening of the bid as specified, the bids will be opened on the next date at the same time and venue.

The bid for the work shall remain valid for acceptance for a period not less than 90 days after the deadline date for bid submission. Other details can be seen in the bidding documents. The officer inviting tender shall not be held liable for



It is the bidder responsibility to verify the website of the information related to the tender.


#### **SPECIAL TERMS AND CONDITIONS OF CONTRACT:**

1. Fitness Certificate from the appropriate authority i.e. of the complete equipment's installed in the Amusement Park on daily basis shall be arranged by the successful bidder on its own.
2. The highest bidder will arrange insurance Cover Certificate in respect of each person riding the Amusement Games.
3. All Rules and Regulations of MC Solan/Distt. Solan Administration meant for putting up Amusement Games at the above said event, shall be adhered in all respect by the highest bidder.
4. The highest bidder shall ensure the norms of sound and smoke pollution while plying the equipment's.
5. The highest bidder shall submit the Fitness Certificate well before the start of Shoolini Fair & as well as on daily basis to the undersigned otherwise you will not be allowed to operate the Jhullas.
6. The area of installation of the Amusement Park/Jhulla will be 1500.00 Sqmtr. Any violation of area, Charges per Sqm will be charged extra of the quoted rates.
7. The Municipal Corporation, Solan shall not provide the electricity connection for the purpose. The electricity connection will be arranged by the Party along with safety certificate from Competent Authority. No other stalls except Jhulla and Joy rides will be allowed to the successful bidder in the Amusement Park area.
8. Any activity other than the said contract, if found carried out by the successful bidder, the entire contract shall be cancelled immediately and the entire earnest money deposited with the M. C. Solan shall be forfeited apart from suitable action as deemed fit shall be initiated.
9. The highest bidder shall ensure the complete cleanliness in and around the Amusement Park.
10. All joy rides should be well polished as well as the tin sheets used for cordon the area designating for installing Amusement Park.
11. The successful bidder shall ensure the complete safety of the Jhullas/Joy Rides etc and any mis-happening whatsoever happens shall be the sole responsibility of the agency.
12. Any dispute shall be subject to the jurisdiction of Solan only.
13. Tender shall be accepted only to that bidder who will produce the certificate of ownership/Authorised Affidavit from owner of amusement Parks with Physical submission of document.
14. All the joy rides shall be allowed to play or valid only for three days i.e. 24, 25 and 26 June 2022 .
15. The You have to deposit full amount of bid before starting the shoolini fair or before 24.06.2022 (A.N.) during working hours.
16. You are required to arrange permission from District Administration and Superintendent of Police deptt. on its own.
17. If any complaint from general public regarding misbehaves by the employee engaged by the bidder, Rates of Jhulla/rides found/ received in this office, necessary action under law will be initiated against you. Successful bidder will have to issue identicard to the employees engaged and compulsorily be tagged on the shirt of the employee with seal/stamp of Bidder.
18. Bidder will have to display sign board of rates fixed by the M.C. Solan in front of every Jhulla/rides before starting the Jhulla/ rides.
19. Rate/charges of Small Joy rides shall be Rs. 30/- per person and Giant wheel and big Crossing Jhulla Rs.50/-per persons. If any complaint from the general public received regarding Rate/charges of Jhulla MC will charge Fine Rs. 1,00,000/- per day and Contractor will be blacklisted for the next time
20. First Three highest bidder will be called for open Auction and Tender will be awarded to the Highest Bidder only .
